What is Simply Giving?

Through *Simply Giving*, your contributions are made through a pre-authorized withdrawal from your bank account. You determine the frequency of your automatic contribution - weekly, semi-monthly, or monthly - the option is yours. Your contribution is deposited into the recipient's bank account on the same day it is withdrawn from your account.

What are the benefits to you and New Life Church?

Simply Giving is a reliable, safe way to move your financial stewardship plan into action. It allows you to share your generous gifts through planned giving in an automatic way. Because your contribution is given consistently, you won't need to play "catch-up" at year-end or worry about forgotten checkbooks or missed Sunday offerings. Your church benefits from steady, more predictable revenues throughout the year, more efficient bookkeeping, and greater confidence in meeting its financial commitments.

How do I participate?

To enroll in the *Simply Giving* automated giving program from Thrivent Financial complete the enrollment form on the next page of this brochure.

Instructions:

1. Using black ink, complete the personal-information section including name, address and telephone numbers.
2. Indicate whether this is a new enrollment/authorization, a change in amount or change in account.
3. Indicate the account type, routing number and account number. Attach a voided check or savings deposit slip to the enrollment form.
4. Sign on the authorized signature line.
5. Complete the sections related to your contributions:
 - ◆ Select the frequency of your contribution.
 - ◆ Indicate the Start Date and your Church envelope number, if applicable.
 - ◆ Designate where you'd like your contribution to go and the amount.
